Division President's Report. Kevin Hoffman gave an update on discipline

• Reminder: Teams cannot agree to waive and the refs cannot waive the player pass requirement.

Division Secretary (Jeff Wilson).

- The minutes of the January 2017 meeting were approved as written.
- Jeff mentioned that teams should let him know if they want help in getting press on tournament victories, etc. No teams reported that they went to the USASA Soccer Fest/Veteran's Cup. One TCSL team went to the O40 Illinois Open Cup. An O48 team from Lake Zurich is planning to attend the Veteran's Cup in the fall.
- Jeff discussed ideas for growing the division and indoor opportunities.

Division Treasurer (Pat Shea).

• Pat provided Kevin with an updated ledger and indicated that the Treasury Balance is appx. \$6,200.

Director of Competition/Registrar's Report (Carlos Solarte).

- Carlos Solarte provided the yellow/red report and noted 100% of the reports were received through the 7-10 games played to that point.
- Referee discussion Carlos will discuss with Referee Assignor (Ted) about ARs who don't run and don't make obvious calls. Frank Schwab requested that the AR names be printed on the game sheets.
- Managers were reminded that if there are issues with a particular referee, email Carlos about it right after the game.
- Managers reminded about late cancellations they are to tell the Assignor and may have to pay to cancel late because referees have committed to the schedules.

Preparation for Fall Season.

- Teams will be divided into two divisions with two rounds of seeded playoffs (1v4 and 2v3 in semi-finals and 5v6 in consolation games; shortened games) and finals in both divisions all at Celtic Park.
- Games will start 9/8. Goal differential will be capped at 5 per game. (Motion by Frank, seconded by Ian Lewis; unanimously approved.)
- Games will be played on Friday evenings (6:30 or 6:45 pm default time).
- Only fields planned to be used in the fall are Celtic, Viking, Lippold, Brickyards, and Libertyville Complex. Carlos will adjust the McHenry and Beese maps.

New Business.

- Marinko Novakovic requested that Father's Day be skipped in next year's schedule. This will go on the January meeting agenda.
- Team roster caps discussed. No agreement to limit them. (Limit of 18 players on game day still applies.)
- Elections will be held for board positions at the January meeting. (Motion to defer elections by Frank, seconded by Marinko; unanimously approved.)
- Discussed indoor options including a presentation by Angel Garcia of O40 and O48 indoor leagues at Canlan Sportsplex Lake Barrington. Angel also offered to host a 1-day tournament on their full-size field at \$200-225/game.

Motion to adjourn the O-40 meeting passed unanimously. Meeting adjourned at 8 PM.
